





Growth of the senior population

The number of Tennessee seniors 60+ is expected to increase by 30 percent from 2020 to 2040. The number of seniors 80+ is expected to double during this time.





Tennessee has three publicly-funded programs to help support low-income elderly Tennesseans.


- TennCare CHOICES (Medicaid)
- Options for Community Living
- Older Americans Act (OAA)




TennCare CHOICES

- State + Federal (Medicaid) funding
- Nursing facility care and lower cost home- and community-based services
- Depending on qualifications, potential choices are in these three groups:
 - Group 1: qualify for nursing facility care
 - **Group 2:** qualify for nursing home care but able to receive home- and community-based services instead (up to the cost of nursing home care)
 - Group 3: low-income seniors who receive Supplemental Security Income (SSI) and are at risk of needing nursing home care if they do not receive long-term services and supports


In TennCare CHOICES, the percent of seniors in nursing facilities compared to home- and community-based services has remained nearly the same for the last five years.



In TennCare CHOICES, the number of seniors served in nursing facilities and HCBS Group 2 remained steady for the last few years. HCBS Group 3 declined.



Under TennCare CHOICES, average expenditures per person varies from most expensive in nursing homes to least expensive in HCBS Group 3.





Options for Community Living

- State funded for Tennesseans age 60 and over at risk of becoming Medicaid-eligible. Services are intended to allow recipients to remain in their homes. Administered by Tennessee Commission on Aging and Disability (TCAD) and AAADs.
- Accepts only as many people as state funding allows.
- Services include:
 - Personal care
 - Homemaker services
 - Home-delivered meals
 - Transportation services



Options program – key stats

- Capped at \$5,000 per person average expenditure of \$3,287 in FY 2020.
- \$9,309,202 in expenditures for Options in FY 2020.
- As of November 2021:
 - Enrollment: 4,145
 - Waitlist: 3,981



Older Americans Act services


- Direct services under OAA are similar to those provided under Options as well as TennCare CHOICES HCBS services:
 - Homemaker services
 - Personal care
 - Home-delivered meals
 - Caregiver support
- TCAD distributes funds to the state's nine Area Agencies on Aging and Disability (AAADs) to help contract with providers to implement programs in their areas.

Older Americans Act – key stats

- State + federal funds FY 2021: \$21.8 million federal and \$2.1 million state
- 23,996 Tennesseans received OAA direct support services in FY 2021
- OAA programs are federally mandated and largely federally funded with limited discretion by Tennessee officials to affect the administration of the program



CHOICES, Options, and OAA represent a range of public programs that provide care for Tennessee's low-income seniors.



OF THE TREASURY

Issues of current concern... but some help is on the way

- Public programs and services designed to prevent or delay seniors from needing higher-cost services are currently unable to serve all who could benefit from the services.
 - CHOICES Group 3 has decreased in enrollment.
 - Options and OAA continue to have wait lists.
- The number of unlicensed residential facilities has grown.



Policy considerations presented in the April report addressed with more money in 2022-23

- Expand home- and community-based services.
 - Expand eligibility for CHOICES Group 3 (approved by the General Assembly – Public Chapter 1130)
 - Expand Options for Community Living to eliminate the waitlist (approved by the General Assembly – Public Chapter 1130)
- Address front-line workers' pay.



Policy considerations presented in the April report for future consideration

- Expand community-based residential alternatives for low-income individuals as well as family caregiver support.
- Continue the additional support for caregivers that occurred through federal COVID-19 relief funding.
- Address the growth in unlicensed residential facilities housing elderly individuals & expand community-based residential options. Public Chapter 1081 requires a registry of unlicensed facilities to be maintained by TCAD.
- Address front-line workers' pay. Public Chapter 1138 establishes a task force to report on this broad issue to the General Assembly with recommendations by December 31, 2023. Current context includes high general cost inflation.






Age-friendly communities in TN:12 10 cities, 2 counties (and Ft. Campbell)

- 54% are working caregivers
- Spending an avg of \$7,242
 per year on caregiving expenses
